#### **Board Roundtable Discussion**

Ohio Facilities Construction Commission – South Central is currently considered a Lapsed district because we did not take the opportunity to build a new school the first time we became eligible. We are still eligible for funds and can still receive the benefits of the OFCC. We have until October 2019 to decide of we want to come out of lapsed status or continue in lapse status. If we choose to come out of lapsed status we will need to get community involvement/support now. Steve Roko could come and give a presentation to the board at the next meeting to discuss our options. The Board would like to have a discussion with Steve from the OFCC at the next meeting.

### **Administrative Reports**

Mr. Hellickson took an opportunity to publicly thank the summer custodial staff for all their hard work to get the high school building and grounds looking great! He went on to show his gratitude for the painting done in the high school hallways, locker rooms, outside entry ways, etc. Mr. Hellickson explained how the data was rolled out to the staff at the start of the school year and how this data will be used throughout the school year.

Mr. Richards shared a breakdown of the data from the AIR tests in the third and fourth grade. The data was broken down by question, learning standard and when the standard was taught. This information will quickly allow the teacher to see gaps, overlaps or a good balance.

Mr. Chaffee discussed the purchase of a new lawn mower with the board from Keefer Lawn and Garden in North Fairfield, they submitted the best bid that was obtained. Deputy Mitch is requesting that we replace the DARE curriculum in the 7/8 grade with The Truth About Drugs.

Olena Sales and Jeff Deeble, transportation and B&G supervisor were in attendance to discuss the buses. All the buses that were finished passed inspection. Bus 10 and 5 are still in the shop, bus 5 should be finished by the end of the week and ready for inspection. Each van needs work. A radio for bus 6 needs to be ordered as it has the shop radio in it right now. Bus 6 currently has the check engine light on. An attachment for the computer had to be ordered because the plug was changed on the new buses. Once this attachment arrives the check engine light will be addressed.
