#### **FFA Presentation**

FFA members, Hunter Cooper and Emily Keene began the presentations to the Board by providing a synopsis of events the FFA has been involved in from the summer until now. They have participated in an officer's trip over the summer to Cleveland, had summer home visits by Mrs. Lucha in preparation of the Huron County fair, Camp Greenhand, District Urban and Rural soil competitions, Forestry competition and setting up at the Huron County Fair Grounds for the Fall Harvest Maze. The students have had a variety of experiences over the past several months.
