Administrative Reports

Darren Hunt updated the board on the many student athletic highlights of the spring season. In addition, he informed the board of the 2018-19 partnership between South Central Local Schools and FTMC to provide athletic training services to the student athletes on a regular basis. The cost of the services will be approximately \$6,000 per year. Mr. Hunt also shared with the board the new football helmets that the athletic department is purchasing this year along with the Boosters and a grant through FTMC. The new helmets are supposed to help prevent concussions and FTMC is hoping to be able to renew the grant for the area schools.

TJ Hellickson provided the board with many highlights for the end of the school year. SC had eight students meet an alternative pathway for graduation by meeting the Ohio Ag Business Industry Credentials. All SC students met the traditional graduation methods. Academic Awards will be May 22nd at 6:30 p.m. Graduation is Sunday, May 27th at 2 p.m. Mr. Hellickson also shared ProCore data in all core subject areas over the past years.

Alicia McKee presented intervention specialist, Mike Strayer, with the Franklin B. Walter Outstanding Educator Nominee certificate. Mr. Strayer teaches in the 4-9 resource room in the 300-hallway working with our special needs students.

Mrs. McKee shared with the board the final wrap up with the board on the schedules for the upcoming school year, interventions, other year end events, and looking ahead for the 2018-19 school year.

Nate Richards provided the board with his end of the year MAP data in math and reading and showed the percentage of students who had met their yearly growth goal. In addition, Mr. Richards shared the highlights of Right to Read week, upcoming Field Day and Move Up Day. He also shared that the spring test results will be available the first week of June for the staff.

Ben Chaffee shared with the board about the highlights of Senator Gayle Manning's visit in April. Also, the transformer in the K8 custodial room is being replaced and BCU Electric will be doing the work at a cost of approximately \$5360. There is a third-grade student who may need summer tutoring to pass the Third Grade Reading Guarantee, we will know more after the results are back in June. If a tutor is needed they will be paid the SCEA contracted rate of \$20/hr. Mr. Chaffee ended his report with upcoming year end events.

Jeff Deeble spoke with the board about the new buses that the district may be purchasing including sharing a spreadsheet of option prices for the two buses. The board discussed the option of purchasing a bus with under carriage storage on one of the buses for sports gear and band instruments along with school lunches for field trips.
